MESSAGE FROM THE PRESIDENT, JACK JOHNSTONE



Canadians owning property
in the United States

Our Secretary, David Hector, thought you should know that:

- (1) Effective January 1, 1985 gains realized on the disposition of property situated in the U.S. and owned by Canadian individuals may be taxed by the U.S. in accordance with U.S. domestic laws (Canadians may claim a foreign tax credit for any U.S. taxes paid on a gain). For property owned on September 26, 1980, U.S. tax will only apply to any gain over the value at December 31, 1984. Gains on property acquired after September 26, 1980 will be fully subject to tax. Sales in 1985 may be fully exempted by electing the treatment under the previous tax treaty.
- (2) U.S. federal estate taxes are levied on non-residents. If your equity in your property is in excess of \$60,000 your estate will pay taxes of 6% on the first \$40,000 of any excess and 12% on the next \$400,000.
- (3) Although the exceptions are broad, under certain circumstances the purchaser is obligated to withhold up to 10% of the gross selling price of a property and remit to the IRS.
- (4) The Foreign Investment in Real Property Tax Act of 1980 imposes an annual reporting obligation on foreign persons who hold a direct investment in U.S. real property having a value of \$50,000 U.S. or more. (The regulation specifying the requisite information has not yet been issued).
- (5) A number of States have their own reporting requirements and assess income and other taxes.

Perhaps you should talk to your tax advisor about your own situation. It may be advisable to transfer your property into a Canadian corporation prior to the end of 1985. This would avoid U.S. estate taxes and could provide an opportunity to avoid or defer U.S. capital gains taxes.

HOLIMONT SKI PATROL SKIER SAFETY MONITORING PROCEDURES

1. The Holimont Ski Patrol will be responsible for monitoring skier safety as outlined in the New York State Industrial Code Rule 54, section 54.4 - Responsibilities of Skiers.
2. Disciplinary action will be taken as follows:
 - a) Guest: First Offense; Patroller will explain violation to guest and one (1) corner of lift ticket will be removed.

Second Offense; Lift pass is removed, name of skier and sponsoring member is recorded. Skier is told to report to officer if he wishes to discuss violation with safety committee; otherwise, skier is requested to leave the area. Patroller will submit with names, a brief description of violation.

Second or flagrant offense will automatically rescind guest's skiing privilege for the day and will forfeit sponsoring member's guest privileges for two (2) weeks.
 - b) Member: First Offense; Patroller will record name of member and brief description of violation and submit to safety committee.

Second Offense or flagrant first offense; Upon receipt of member's name and violation, lift pass will be removed for that day by the safety committee. The member shall then be notified by the safety committee in accordance with by-law 4.7 and procedures toward suspension will begin.
3. The Skier Safety Committee will be comprised of members designated by the Board of Directors.

MESSAGE FROM THE PRESIDENT: Jack Johnstone

On January 19th at 3 p.m., approximately eighty-three Holi-mont members attended the announced informational meeting and were able to review the Real Estate and Financial Committees reports on the acquisition of the Bibb's property. In order to aprize the membership, several real estate maps were reviewed with reference to the area purchased and the future of the new area along with Scotty's special map showing possibilities of adding additional ski lifts. The directors were very pleased with the attendance and we believe most all questions were answered from the floor. In order to show interested members the new area and development potentials our Mountain Manager "Scotty" has been commissioned to offer special trips of approzimately seven people aboard the IMP for an hour's tour, leaving at 3:00 p.m. each Saturday. (Meet behind the Main Chalet.)

Director/Treasurer, Jack Swanson, has been appointed Chairman of the John Bibbs property (Not yet named) development. Jack has spent a lot of time on this project along with the Real Estate Committee and he will be in touch with those who are interested to review single and multi-development unit plans for ski-in and ski-out facilities, potential lift sites, lake and/or water reservoir for: ecology, flood control, snowmaking, fishing, swimming, and "no sailing". Water for snowmaking is very important to Holimont. As a matter of interest snowmaking was stopped last week because of low water in our pond. Plum Creek was dry.

Director Don Richardson and committee have been asked to enlist Butch Cannon, George Smith, and Stu Durham for starter to immediately review a plan for Main Chalet expansion. This project will be one of our major considerations this year.

Director Rod Jones will be heading the newly formed computer study group and has been authorized to purchase a system for next year which will help us in areas of payroll, personnel, reserv ions, purchasing, and maintenance along with many other areas.

Barbara reported that we had as many as 250 to 300 no-shows Saturday, February 16th. Members who call for guest reservations must also cancel. You are preventing someone else from skiing that day. Members, in order to help your guests ski earlier on Sundays, please let them know that after 3 p.m. on Saturday they can purchase tickets for the next day as long as they are registered as your guests. Help your guests to be skiing earlier.



A STATUS REPORT ON THE DEVELOPMENT OF THE BIBB'S PROPERTY

As most HoliMont members are aware, the club has purchased the property to the west of Hilltop Road, known as "the Bibb's Property". Our plans are to develop this property with housing sites and a ski lift for the growth and benefit of the members of HoliMont.

President, Jack Johnstone, appointed a committee consisting of Jack Swanson, Ted Tarbell, Mike Francesco, and Jerry Grassi, to expedite the development of this area. The committee has been working full time, but there are many details that must be addressed before it's possible to present a plan to the membership.

This report is intended to inform the membership of the current status and to put to rest many rumors which have surfaced concerning this development. It is important to recognize that this information is tentative, and is based on the facts that are known at this point in time. Delays may be encountered, or changes may be made based on information that will develop in the course of our plans.

The committee sees the development taking place in 3 phases:

Phase #1--

The development of 40 to 50 housing units on property that is accessible from the HoliMont entrance road. These units would be a mix of multiple housing and single family homes. The cost of water, sewer, and roads will to a large extent determine the density. These housing units would have a ski in, ski out access to a trail that would lead to the base of a future lift which would allow a connection to trails at the top serving the Exhibition Lift. It is hoped that the main lift slope could be cleared this summer, and a plan showing the arrangement of the lots and housing units would be available for the membership at the annual meeting in October.

We would like to make lots available early this summer, but the amount of work that needs to be done will probably not allow this to happen. There are so many details that require resolution that it would appear that the earliest the plans can be presented to the membership will be in October.

Phase #2--

This will involve the actual construction of a lift from the base of the Bibb's property to the top with trails on either side that will give some very interesting skiing. Many members have availed themselves of Scotty's tours of the new area, and have seen the bowl to the west which is a skiing dimension not currently available at HoliMont. It is possible to create a lake at the base which will be larger than our present pond, and will provide us with a better source of water for snow making. Housing sites and roads will be placed so that they compliment, but do not interfere with the skiing. Again, it should be possible to ski in and out from any one of the housing sites. Phase #2 cannot proceed until Phase #1 is completed as the income from Phase #1 will allow the next step to be taken. A timetable has not been established for this phase, but it would seem that a lift could not be built before the summer of 1987. This is all predicated on other demands for club funds. We will be faced with priorities, and what is considered most important for the club at that time.


Phase #3--

All of the developments that we have described are east of Canfield Hill Road. The development of the property lying to the west of this road is probably at least 10 years in the future. There will be new club management, different ideas, and questions regarding the size of the club that must be solved before Phase #3 can take shape.

The speed at which we are able to solve detail problems and present a plan for Phase #1 will, of course, determine how fast the housing sites are sold. This, in turn, will directly influence the start of Phase #2. The club has many other potential projects such as improvements to the main chalet, grooming and snow making equipment, a possible change in our electrical power distribution, and other projects which are too lengthy to list in this report. The priority of all of these projects will determine how fast the development of Phase #2 will proceed.

Many members have expressed an interest in owning property in the new area. Keep your interest alive because this will be a most desirable location for housing and the enjoyment of skiing. Take a tour with Scotty. He knows every tree and gully in the area. Your committee intends to make this a first class area in every respect, hopefully benefiting by experience gained in past developments.



A DAY ON THE JOB - FOR A SKI PATROLLER

To describe such a day encompasses a great many different things. We arrive at the area half an hour before the slopes open to sign in and be ready to go with the movement of the chair lift. First run is to check your assigned slope and report back to the patrol room with information about current conditions. This process is repeated in the afternoon. Any changes are recorded and if necessary recommendations noted regarding the safety of the slope.

If you happen to be equipment officer, it would mean checking equipment, readying it for the days activities and making sure all the toboggan huts have sleds inside in good working order. It may be necessary to have used sleds returned to the hill. Equipment needing repair must be brought in or fixed on the spot.

Chief of the day is responsible that all patrollers assigned are ready to go to their area and come back with reports. All patrollers are responsible for their own subs if they cannot make a duty assignment. In the event a scheduled Patroller is not comered, the chief of the day must see that someone covers the assigned duty.

Meanwhile, the ski patroller is on the hill helping anyone who loses equipment with a premature release, returning poles or stray skis lost in a fall, as well as answering all calls for assistance. Some calls are real, some are flase alarms, but all are responded to with the same enthusiasm and readiness for any situation.

An example of some of the types of emergencies handled cover the range of life threatening to minor wounds or sprains. The men and women of the patrol care for toddlers in tears as well as adults the size of blockers on a football team. Emergency first aid is given to all injured with the skills acquired from many hours of training and refresher courses.

Each year an 8 hour American Red Cross advanced first aid refresher class is mandatory. An annual refresher of CPR skills is also required. During the first aid refresher we also do a prectice chair-evacuation to test skills and equipment. Within the Holimont patrol we have many American Red Cross first aid certified instructors as well as CPR instructors.

When the snow is on the hill there is also a four hour refresher course in outdoor emergency first aid done in the snow. This practice problem is always of a serious nature involving the use of a back-board and special splinting. The rest of the on-the-hill refresher is ski & tobaggon handling.

Within our patrol we also have certified examiners for the National Ski Patrol System in both first aid and ski and toboggan skills. This certification takes a great deal of skill and time to acquire. These people work as trainees in the process of becoming certified to examine other patrollers. You can be proud of the accompolishments of Holimont patrol.

It may not be easy to recognize all the patrollers involved in other than on the hill patrolling, but you can see some things by looking at patrol parkas. All patrollers have a National Ski Patrol System patch, but those with Senior rockers indicate a higher level of accompolishment. A star indicates an honorary appointment with a number designating the patroller has performed above and beyond the call of duty.

As you can see from what is covered above, a day on the job for a ski patroller is not easily come by. A lot ofwork and dedication go into being prepared to be on the hill serving the skiers. For every patroller you see, there have been countless others involved to be sure the rust parka is worn by a qualified, well equipped and caring individual.

REPORT TO THE MEMBERSHIP: JACK JOHNSTONE : May 21, 1985

The skiing season is over, and now that most everyone's thoughts have turned to lush greens and blue waters or other summertime activities, your Directors still need your assistance.

Enclosed with this Holi-Leaf is a very important request from the Real Estate Committee which will help to identify the direction and areas of interest of our members. The Real Estate Committee is on a schedule to present a three-phase program of development of the Bibb's property and will have a comprehensive report with details on single and multi-dwelling units prepared for your review at the October Membership meeting. This will also include slope layout.

The Membership Committee has enclosed a report which consists of new members applicants that have been reviewed by the Membership Committee, presented, and accepted by the Board for Members final approval.

As many of you are aware, last year's skiing season started in January and ended March 31 giving us 79 total days of skiing. Our normal number of skiing days is over 100, and we did not have skiing during Christmas and New Years Holidays. The lifts were shut down at the end of March to avoid a high April billing for demand power. We ran out of skiers before we ran out of snow.

Due to this year's short season and particularly the unanticipated guest income loss of approximately \$56,000.00 during Christmas and New Years, along with our older members not skiing as much, 119 members not picking up their paid-for yearly passes, not bringing as many guests, which supports our operating income, the Board has proposed the 1985-86 yearly assessment be \$500.00 per active membership.

Last year because of a prior excellent year we were able to reduce the yearly assessment by \$150.00. This is now considered to have been a charitable move which may not be advisable in the future. A recap of the last 6 years dues and assessments should substantiate the Boards recommendations when considering the almost doubling of the clubs size in this same period of time:

5. Online computer program certain phases completed by start ski season 1985 with published financial statements 1986.
6. Sale of three lots bordering Holi-Mont entrance road restricted to single dwelling family units.



The Board of Directors recently approved the following regulations regarding Special Lift Passes.

SPECIAL LIFT PASS REGULATIONS

1. A divorced and not remarried Active or Junior Member may have passes issued to those of his children who qualify according to the Bi-Laws. In addition special application may be made to Operations Committee to have a special pass or passes issued to a specific person or persons who is/are part of the family unit.
2. A divorced and remarried Active or Junior Member may have passes issued to his new spouse, to his children who qualify according to the By-Laws, and to the children of the spouse who are living in the household or are in school and supported by the Member.
3. Widowed Active or Junior members same as (1) and (2) above.
4. Separated Active or Junior Members will continue to be issued passes only for family members who qualify according to the By-Laws.
5. AFS students and foster children will be treated individually only on specific application to the Operations Committee.
6.
 - a. An Active Member who voluntarily retires as a result of a divorce may apply to the Board of Directors within 12 months for a new membership, and the Board may accept him as a new Member of the Club subject to payment of initiation fee. He would go to the top of the waiting list.
 - b. If an Active Member retains his membership following a divorce, his spouse may, within 12 months, apply to the Board of Directors and the Board may accept such spouse as a new Member subject to payment of Initiation fee. Such spouse would go to the top of the waiting list.
7. Husband and wife Active or Junior Member without skiing children:
 - a. One spouse no longer skiing, give special use pass to skiing spouse.
 - b. Non-skiing spouse may not use special lift pass.
8. Season or daily lift passes may not be sold by an Active or Junior Member. A season pass may be issued to a "significant other" friend of a single Active or Junior Member. A single Active or Junior Member who qualifies for a daily guest pass must personally pick up his guest's pass at the window. Ski Patrol, Ski Instructors, and Racing Coaches who qualify for guest passes must do likewise.
9. Entitled to ski as family of a Member are "all of his children under the age of twenty-one years or under the age of twenty-five years and in full-time attendance at any school." Age is defined as of October 1st preceding the ski season in question. Full-time attendance at school is defined according to the definition of the school.

Please note Section 8 very carefully, for in the past there have been some violations of these rules.

SENIOR MEMBERSHIP

The plans for the new area known as "HoliMont West" or "Sunset" are progressing in spite of some governmental road blocks. REPORT TO THE MEMBERSHIP: Jack Johnstone

WELCOME BACK: To coincide with the Ellicottville Octoberfest, which will be held weekend October 12 and 13, please note the Holi-Mont Annual Membership meeting will be held at the main chalet Saturday, October 12 at 1:30 p.m. A separate meeting notice, with proxy, bylaw recommendations, financial report, and return envelope will be mailed to you in the middle of September. Please sign and return the proxy, even if you plan to attend. You may withdraw your proxy once you arrive, however, this will assure us of a quorum so we may proceed with the meeting. The Board of Directors encourages you to attend.

This year's largest project has been the acquisition of the Bibbs property area to the West ("yet unnamed"), which we will have available for your personal walking inspection by using the Exhibition Chair prior to the annual meeting. Pete Widger and Scotty Lavtar have reported that the Phase I slope cutting, clearing, and stump removal will be completed for you to view the tremendous potential of this new area. Mr. Swanson, Francisco, Tarbell, and Althans will have a proposed project development presentation with contour maps and additional information available for the annual meeting. We are confident you will agree the development has a great potential for Holi-Monters who want to "live on the slopes" "ski in and ski out".

This summer has been extremely busy with many projects to improve our skiing conditions. The electrical problems we have encountered over the past years, particularly overloading the systems which were not designed to handle our continuous growth should now be corrected. The Exhibition Chair area has been completely upgraded to include a new 1000 KVA transformer with a new cubicle, and new wiring, which will now accommodate all our needs presently plus allow for future expansion. The ability to use new circuits and remove old circuits, will eliminate old demand meters which will substantially reduce one of our most expensive operating costs.

Due to many requests over the past several years, Mr. Don Richardson, Chairman of the House Committee, has been asked to present at the annual meeting a program we have under study for the expansion of the main chalet. According to George Allen, a member of Don's committee, it has been over ten years since we have made any major changes to our chalet. I know you will like this presentation.

We are happy to welcome back Scotty and Barbara Lavtar, Mike Polasik, and Peter Widger, Administrative Manager, who will be joining us for a second season. For those of you who wish to be first, Barbara will be available Saturday and Sunday to take membership pass pictures. The hours will be posted at the chalet.




Every year at this time as we send out invoices for the new season, we find that a number of people have moved and have not so advised us. At the present time we do not have current addresses for the following people:

THIS PLAN IS UTILIZED ALSO BY THE VOLUNTEER RESCUE SQUAD OF ELLICOTTVILLE AND A MORE DEDICATED, KNOWLEDGABLE GROUP WOULD BE DIFFICULT TO FIND.

IN AN EMERGENCY THIS INFORMATION ON YOUR TELEPHONE IS VITAL TO WHOMEVER IS CALLING FOR ASSISTANCE. MORE AND MORE GUESTS ARE IN RESIDENCE, SOME ON A RENTAL BASIS THUS WOULDN'T KNOW THE OWNERS IDENTITY, AND THE FIRE-RESCUE SQUAD NEED TO KNOW THE NUMBER-LETTER FOR QUICK RESPONSE.

IF YOU DO NOT HAVE THIS INFORMATION, PERHAPS YOU'RE IN A NEWLY CONSTRUCTED CONDO, PLEASE CONTACT ME. I HAVE SPOKEN TO JOEL CARSON WITH THE ELLICOTTVILLE VOLUNTEER FIRE-RESCUE SQUAD AND HE IS ANXIOUS TO UP-DATE THEIR PLAN. HE AND DICK RIVERS HAVE SPENT CONSIDERABLE TIME AND EFFORT IN FORMULATING THIS BUT IT REQUIRES REVIEWING FROM TIME TO TIME. PLEASE, TAKE A MINUTE THAT COULD PROVE SO IMPORTANT SOME DAY: LOOK AT YOUR TELEPHONE.. IF YOUR LETTER-NUMBER IS NOT THERE, PUT IT ON. REPORT FROM THE REAL ESTATE COMMITTEE AND THE TREASURER

As most members know, HoliMont purchased the property to the west from John and Ethel Bibbs last winter.

The purchase price for this property was \$500,000 and we obtained a bank loan for \$400,000 to complete our financing package. The loan is secured by a stream of membership fees that are already in place.

These figures are approximate and conservative, but you can see that the bank loan can be returned in 4 to 5 years.

The development of this area would proceed in 3 phases, and would be financed by the sale of single building lots to members or multiple housing lots to developers.

The Real Estate Committee has worked spring and summer with Scotty, Pete Widger, and our engineer to come up with an acceptable residential development plan. It then became apparent that to make the lots more attractive, it was necessary to clear the main slope in Phase 1 so that prospective purchasers could clearly visualize the beauty and convenience of the new area.

The main slope has been cleared. It is a new dimension not available anywhere in the east. Not only will it be great for intermediates, but our hot boys and girls will enjoy cruising on its 2,600 ft. slope with a 550 ft. drop. This is not a ski trail, it is a ski slope with a constant grade top to bottom.

The sale of lots is the key to the building of a lift and the development of Phase 1. Some of these costs may be summarized:

The Board of Directors recently approved the following regulations regarding Special Lift Passes.

SPECIAL LIFT PASS REGULATIONS

1. A divorced and not remarried Active or Junior Member may have passes issued to those of his children who qualify according to the Bi-Laws. In addition special application may be made to Operations Committee to have a special pass or passes issued to a specific person or persons who is/are part of the family unit.
2. A divorced and remarried Active or Junior Member may have passes issued to his new spouse, to his children who qualify according to the By-Laws, and to the children of the spouse who are living in the household or are in school and supported by the Member.
3. Widowed Active or Junior members same as (1) and (2) above.
4. Separated Active or Junior Members will continue to be issued passes only for family members who qualify according to the By-Laws.
5. AFS students and foster children will be treated individually only on specific application to the Operations Committee.
6.
 - a. An Active Member who voluntarily retires as a result of a divorce may apply to the Board of Directors within 12 months for a new membership, and the Board may accept him as a new Member of the Club subject to payment of initiation fee. He would go to the top of the waiting list.
 - b. If an Active Member retains his membership following a divorce, his spouse may, within 12 months, apply to the Board of Directors and the Board may accept such spouse as a new Member subject to payment of Initiation fee. Such spouse would go to the top of the waiting list.
7. Husband and wife Active or Junior Member without skiing children:
 - a. One spouse no longer skiing, give special use pass to skiing spouse.
 - b. Non-skiing spouse may not use special lift pass.
8. Season or daily lift passes may not be sold by an Active or Junior Member. A season pass may be issued to a "significant other" friend of a single Active or Junior Member. A single Active or Junior Member who qualifies for a daily guest pass must personally pick up his guest's pass at the window. Ski Patrol, Ski Instructors, and Racing Coaches who qualify for guest passes must do likewise.
9. Entitled to ski as family of a Member are "all of his children under the age of twenty-one years or under the age of twenty-five years and in full-time attendance at any school." Age is defined as of October 1st preceding the ski season in question. Full-time attendance at school is defined according to the definition of the school.

Please note Section 8 very carefully, for in the past there have been some violations of these rules.

REPORT FROM ROD JONES:

Final drawings are not complete and this is the time for your input for the interior lay-out. Your ideas or concerns should be directed toward Pete Widger, Scotty Lavter and Joyce Evans or any member of the board. We appreciate your efforts. Construction is hoped to begin in the spring of 1986 with completion in time for the ski season.

RACING NEWS

Winter is getting closer and so is the 85/86 racing season. Almost all of our coaches from last year are returning, and there will be some new ones. Cindy Oak, recently retired from the US team will be coaching at Christmas camp, and perhaps through the season (depending on availability). Her goal is to help make Holimonters the fastest in Western New York, and she wants everyone to show up in good shape from Fall training. After a terrific year in 85, we are looking forward to an even better one in 86. (How better? -- How about snow at Christmas?)

Program applications and descriptions, and sweatshirt order forms are included below. Please fill out and return them. Being soft-hearted, we may let you join the program later. However no sweatshirts can be ordered after December 1st. Also, please renew your memberships in NYSSRA and the USSA.

A WORD ABOUT EQUIPMENT. If you are planning on buying new equipment for your kids (or anyone else) : skis should be 3 or 4 inches taller than the child (a bit more for adults) and be flexible; poles should have handles with straps that wrap around the wrist, not grips that encase the hand; boots should naturally cant the leg forward and have some forward flexibility; bindings should match the skier's weight, be compatible with the boots, and have shock-absorbing capability.

The following is an outline of the coming season with, we hope, something for everyone. Anyone wanting to race should be able to do so at a level of their own choosing. Our program includes USSA class races, NPSC races, Taylor Series, Niagara Cup Races, and improvement of basic skiing and racing skills. In these various races, a racer's class is determined by his age on December 31, 1985.

In addition, there will be some club races at Holimont which will include a race at the end of Christmas Training Camp, a Dual Slalom at the end of our regular season program for program participants, and a Club Championship Race at a date to be announced.

This year there will be a Christmas Training Camp on December 27 - 30, folowed by a race on the morning of the 31st. The Seasonal Program will run for 10 consecutive weekends starting on Saturday, January 4, and ending on Sunday, March 9. The Christmas Camp-ending banquet will be held on Dec. 30.

Listed below are various programs and prices. These are open to all members and guests. In addition, the racing center is available to all, including non-participants, if you need a place to work on your skis. We will be buying wax in bulk and making it available at cost.

An application form is included with this mailing, and we again plead for prompt response. Better and earlier information means a better program. 





SKIER SAFETY



Again in 1986, the Holimont Ski Patrol will monitor skier safety as outlined in New York State Industrial Code; Rule 54.

A committee of volunteer members has been formed to enforce disciplinary actions. They are:

Dave Pitkin, Orchard Park, N.Y. Liason/Board

Disciplinary actions are listed as follows:

1. GUEST First offense: Patroller will explain violation to guest and corner of lift ticket will be removed or red tag will be applied.

Second offense: Lift pass is removed, name of skier and sponsoring member is recorded. Skier is told to report to office if they wish to discuss violation with safety committee; otherwise skier is requested to leave the area. Patroller will submit with names, a brief description of violation.

Second or flagrant offense will automatically rescind guest's skiing privileges for the day and will forfeit sponsoring member's guest privileges for two (2) weeks.

2. MEMBER First offense: Patroller will record name of member and brief description of violation and submit to safety committee.

Second offense or flagrant first offense: Upon receipt of member's name and violation lift pass will be removed for that day by the safety committee.

The member shall then be notified by the safety committee in accordance with by-law 4.7 and procedures toward suspension will begin.

We hope the Ski Patrol and Skier Safety Committee will be very inactive. You can help as members by making your family and guests aware of safe skiing.

SPECIAL LIFT PASS REGULATIONS

1. A divorced and not remarried active or junior member may have passes issued to those of his children who qualify according to the By-Laws. In addition special application may be made to Operations Committee to have a special pass or passes issued to a specific person or persons who is/are part of the family unit.
2. A divorced and remarried Active or Junior Member may have passes issued to his new spouse, to his children who qualify according to the by-laws, and to the children of the spouse who are living in the household or are in school and supported by the member.
3. Widowed Active or Junior members will continue to be issued passes only for family members who qualify according to the by-laws.
4. Separated Active or Junior members will continue to be issued passes only for family members who qualify according to the by-laws.
5. AFS students and foster children will be treated individually only on specific application to the operations committee.
6. a. An active member who voluntarily retires as a result of a divorce may apply to the board of directors within 12 months for a new membership, and the board may accept him as a new member of the club subject to payment of initiation fee. He would go to the top of the waiting list.
b. If an active member retains his membership following a divorce, his spouse may within 12 months, apply to the board of directors and the board may accept such spouse as a new member subject to payment of the initiation fee. Such spouse would go to the top of the waiting list.
7. Husband and wife active or junior member without skiing children:
a. One spouse no longer skiing, give special use pass to skiing spouse.
b. Non-skiing spouse may not use special lift pass.
8. Season or daily lift passes may not be sold by an active or junior member. A season pass may be issued to a 'significant other' friend of a single active or junior member. A single active or junior member who qualifies for a daily guest pass must personally pick up his guests pass at the office.
9. Entitled to ski as family of a member are "all of his children under the age of twenty-one years or under the age of twenty-five years and in full-time attendance at any school." Age is defined as of October 1 preceding the ski season in question. Full-time attendance at school is defined according to the definition of the school.

Please note sections 8 very carefully, for in the past there have been some violations of these rules.



RACING NEWS

A few reminders in relative order of importance:

- * Pray for snow!
- * Mail in your racing program applications ... please. Applications were in the November 'leaf.
- * Its too late to order our designer sweatshirts by mail. Details also in Nov. 'leaf. Phone orders will be taken until December 15th -- no more reprieves. (Not our fault if 12/15 is 2 days earlier than you receive this.)
- * Enroll in Christmas Camp to get the season off to a good start.

A few words about various races and series follow. A racer's age is his age on December 31, 1985. ie: if you turn 14 on January 1st, you will still be considered to be 13 for the 85/86 season.

EMPIRE SERIES -- for racers 14 to 18, held in western and central New York, generally on Sundays, with entry fees subsidized by the racing club. Better racers can graduate to the trophy series. Seedings are based on the national points list and racers must be members of USSA.

NFSC -- Niagara Frontier Ski Council. For racers approx 8 to 13 (14 year olds not having raced in Empire races may elect to race in this series) 6 races on consecutive Sundays at Holimont, Wing, KB, Holiday Valley, P&P, and Cockaigne. Best in council qualify for the divisionals and further distillations progress to State and Eastern Championships.

TAYLOR SERIES -- A series of 4 races in the spring for 13 and under who have not qualified for the NFSC divisionals. (14 year olds not eligible)

NIAGARA CUP -- A series of three races at Wing, HV, and Holimont for adults and teens who do not participate in the Empire series. Races are followed by a buffet lunch and post-mortems (if anyone died).

There will also be a club championship and a dual slalom. The club race is open to all comers aged 5- to 50+, but the club champion must be a member. The dual slalom is open to all racing program participants who pre-register for it -- amateur status may be jeopardized.

Remember -- pray to the God or Gods of your choice, but make sure we have snow.
